**Terms of Reference**

i. **Statement of objectives:** State Tax Section of Department of Revenue deals with the work taxes levied by State Governments. A scheme for computerization of commercial taxes administrations of States/UTs has recently been launched by the Department. proposals submitted by State/UTs are to be appraised and processed for sanction of the Project Empowered Committee. The basic job of the consultant engaged will be to help Project Monitoring Unit set up under the Project in processing the proposals for sanction, release of funds, and in monitoring the project activities.

ii. **Outline of the tasks to be carried out:**

- a) Preparation of appraisal reports on the proposals submitted by the State/UTs.
- b) Presentation of appraisal reports for approval, issue of formal approvals, expenditure sanctions and fund release.
- c) Collecting, compiling and analysing physical and financial progress reports.
- d) Visiting States/UTs to see the progress of project activities and provide guidance to States/UTs.

iii) **Schedule for completion of Tasks:-**

The work relating to preparation of reports and examination of proposals is required to be executed in a time bound manner for appropriate decision by the superior authorities. The consultant will work under the guidance of Director (State Taxes)
